Kusek presented the Commissioners with the February Cash Report for signature.


<u>DES - Report - Jon Lopp</u>

Resolution FY24.25 #65



Adopting the 2024 Western Montana Region Hazard Mitigation Plan

Whereas, Meagher County recognizes the threat that natural hazards pose to people and property within our community, and

Whereas, undertaking hazard mitigation actions will reduce the potential for harm to people and property from future hazard occurrences; and

Whereas, an adopted Hazard Mitigation Plan is required as a condition of future funding for mitigation projects under multiple Federal Emergency Management Agency pre- and post- disaster mitigation grant programs; and

Whereas, Meagher County resides within the Planning Area, and fully participated in the mitigation planning process to prepare this Hazard Mitigation Plan; and

Now, therefore, be it resolved, that the Meagher County Board of County Commissioners, hereby adopts the Western Montana Region Hazard Mitigation Plan, as an official plan; and

Be it further resolved, the Meagher County Board of County Commissioners will submit this Adoption Resolution to the Montana Disaster & Emergency Services and Federal Emergency Management Agency, Region VIII officials to enable the Plan's final approval. While some content may require revisions to meet the plan approval requirements, changes occurring after adoption will not require Meagher County to re-adopt any further iterations of the plan.

<u>Library Report - Rachel Wahlstrom</u>

Library Co-director Rachel Wahlstrom entered the chambers at 2:30 p.m.

Wahlstrom stated The Friends of the Library (FOL) reached out to her to see if there were any projects the library needed assistance completing. Wahlstrom informed them that the Flag Pole at the library is in need of replacement due to damage from the wind. FOL expressed interest in undertaking that project. Wahlstrom reported the FOL approached the American Legion and the City of White Sulphur Springs for funding the project and were turned down. FOL did not contact the County Commission prior to securing funding from Jamie Doggett.

Wahlstrom announced that the library will be launching a seed library, allowing residents to borrow seeds and, ideally, return any surplus to the collection. Additionally, the library has applied for a grant from Town Pump to support the Summer Reading Program. Next week, the

Friends of the Library will be stepping in to assist, as all four library employees will be attending the 2025 Montana Library Association Annual Conference from March 26th to 29th

Wahlstrom stated that Paul Komlosi has stepped down from the Library Board. There are now two openings on the library Board.
